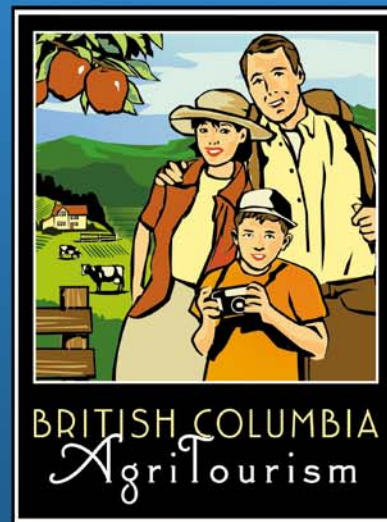

Quality Assurance Program: Required Standards

1. All necessary permits and licences
2. Food Safe / Serving It Right certificates
3. Business hours posted and adhered to
4. Adequate insurance, including liability
5. Marketing information accurate and current
6. Clean toilet facilities / handwashing
7. Handwashing stations (petting farms) / signage
8. Guest areas well maintained and free of hazards

Quality Assurance Program: Recommended

Hospitality and Customer Service

- Customers are greeted and welcomed in a friendly manner
- Staff knowledgeable and able to answer questions from customers
- On-the job staff training, including customer service training

- Access to AgriTourism Insurance Program (Capri Insurance)

- Access to BC AgriTourism Marketing opportunities
- Use of BC AgriTourism accreditation logo

Agritourism Insurance Program



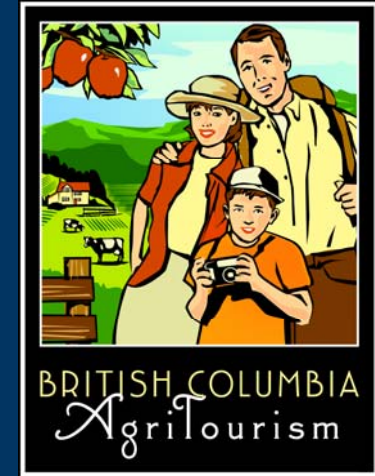
- Many agritourism activities do not have an established track-record for risk management. Because of the uncertainty with these activities, insurance providers consider them high risk.
- Some farmers have been refused insurance, while others have experienced a dramatic increase in liability insurance costs.
